2 COMPOSITION/INFORMATION ON INGREDIENTS

COMPOSITION COMMENTS: Mixture based on inorganic metallic oxides. siliceous mineral filler.

3 HAZARDS IDENTIFICATION

This product is not classified as hazardous under current CHIP regulations

4 FIRST AID MEASURES

INHALATION: Unlikely to occur however if it does, Move the exposed person to fresh air at once. Get medical attention if any discomfort continues.

7 HANDLING AND STORAGE

STORAGE PRECAUTIONS: Store at moderate temperatures in dry, well ventilated areas.

8 EXPOSURE CONTROLS AND PERSONAL PROTECTION

INGREDIENT COMMENTS: Nuisance Dust 8 Hour TWA 10Mg/M3 Inhalable 4 Mg/M3 Respirable

VENTILATION: Provide adequate general and local exhaust ventilation.

RESPIRATORS: Respiratory protection must be used if air concentration exceeds acceptable level. Dust filter P2 (for fine dust).

PROTECTIVE GLOVES: No specific hand protection noted, But gloves may still be advisable. For prolonged or repeated skin contact use suitable protective gloves. Rubber or plastic.
